SEEDS OF CHANGE AND NEW GROWTH FOR UKMIDSS

This is Paula's last newsletter before she heads off into retirement world in June. Always keen on a relevant and topical theme, Paula's final newsletter theme before she 'leaves' is Trees!

This newsletter updates you on the Previous PPH Study, our plans and activities for the next study, and our aspirations for future projects and studies.

Previous PPH is our third UKMidSS study. I'm sure you will agree that in spite of occasional 'environmental' challenges, the UKMidSS has laid down strong roots of support in all UK alongside midwifery units. The UKMidSS research team, which includes all reporting midwives, the Steering Group committee and the small team based at NPEU in Oxford, has grown and changed over time as the studies progressed. We have adapted to manage difficulties and challenges along the way, and have produced robust study findings, the fruits of which bring positive 'climate' change in midwifery practice.

The UKMidSS team is now preparing to branch out further to include freestanding midwifery units in our next study.

And looking ahead, UKMidSS is set to evolve further to develop more sub-study 'branches' similar to the midwifery unit admission criteria project, which all adds up to exciting and busy times ahead.

UKMidSS Previous PPH Study Update

Our UKMidSS map shows all 123 contributing centres and the response to monthly report request emails for August 2018 to April 2019.

- Centres showing as an orange dot are those that have reported for some but not all months.
- Centres with a red dot have not yet started reporting.
- Centres with green dots have completed all their reports!

99% of units have submitted at least one monthly report for the Previous PPH Study which is excellent participation but we do need ALL monthly reports to be submitted. Please check your reminder or status emails to see if you have more reports to submit.

New UKMidSS Study: PPH in Midwifery Units

The next study will investigate management and outcomes of PPH occurring in midwifery units. The first report request is due to be sent out on 1st October 2019. This will be the first UKMidSS study to involve freestanding midwifery units.

We are busy finding reporters for these new centres. Midwife reporters need to be added to our administration system and also given access to OpenClinica before the study starts, and will need guidance and support to get them familiar with the study and systems.

We will be running a webinar training session later in the summer before the study start date. Look out for more information via email soon.

Introducing the new UKMidSS Research Midwife - Ginny Mounce



Ginny is a midwife who has been working in a research role for the Nuffield Department of Women's and Reproductive Health at the University of Oxford for ten years where she worked on studies that focused on infertility and fertility treatments, including national clinical trials. As such she has experience of collecting data for research purposes and hopes to use

this insight to help in her new role with UKMidSS. Previously she worked as a hospital based midwife in several settings, including time in the midwife-led birthing unit in Oxford.

In 2017 she was awarded her PhD from the University of Surrey for her thesis, an ethnography of couples experiences of the early 'infertility journey'. She is particularly interested in investigating patient experiences, to complement traditional clinical research.

We are looking forward to welcoming Ginny to the UKMidSS team in early July.

Midwifery Unit Admission Criteria Project

Over the winter we ran a quick survey to find out about the different admission criteria used by midwifery units across the country. MSc Midwifery student, Ceri Glenister, worked on this project and has sent us this update:

Excitingly, the admission criteria study is nearing completion. There was a fantastic response; 84% completed the survey and 71% responded to the request for admission guidelines. A big thank you to everyone who participated amongst their busy working lives.

Data collection finished in February, I then read all the guideline documents, extracted information from them and compared them to the national guidance in NICE CG190 (Intrapartum care for healthy women and babies). All that is left now is to finish writing everything up, first for my MSc dissertation and then for a paper in a journal. I can't say much about the findings here because we don't want to jeopardise that publication, but in brief:

- There was wide variation in guideline length, layout and content, and in the extent to which guidelines were similar to or different from national guidance.
- We have identified some particular admission criteria where guidelines often diverged from national guidance
